The Gas Machinery Conference attracted over 1,200 attendees to this year's Conference held in Austin. The Conference includes a wide range of short courses, technical papers and technology updates, presented by the industry's leading subject matter experts. 2012 Conference highlights:

- 1,201 total attendees (attendance has increased 35% the past two years)
- 276 total companies represented attendees and exhibitors
- 137 exhibiting companies (a 27% increase)
- 17 countries represented (Austria, Belgium, Bolivia, Canada, China, Columbia, Denmark, Finland, France, Germany, Mexico, Netherlands, Saudi Arabia, Spain, Sweden, Switzerland, and the US.)
- 38 technical papers, 13 short courses, 12 short technology updates
